Mr. Corriston said that because it is just a complaint it is ok once they file a complaint it is public information. There was also a concern that the HA did not note the time the meeting starts. REPORTS TO THE BOARD:

LEGAL COUNSEL- The attorney said that the HA had an eviction scheduled for last month but both tenants paid prior to the court date. The HA has more scheduled for next month. He said that it is necessary to stay on top of that and they have a good routine going now and has resulted in very good accounts receivable. Kuddos to staff! There are big changes coming up, and next year will be a challenge. He then explained the eviction process to the Board.

EXECUTIVE DIRECTOR– The Executive Director said she spoke with the Accountant and the Budget Committee regarding salary increases. She thought that what they came up with was in the best interest of the HA. There are two increases, one for Robert Moeller and the other for Arlene Feula. The other staff members will get two floating holidays instead of an increase.

The Continuum of Care program has closed out and there were no findings. The Joint Insurance Fund they did process a check for the HA of \$11,770 most of all of that work was done in house. Verizon has started the work at Site B.

All the Housing Applications are open and will would like to close the Waiting List on December 21st.

She said that the Community Room at Site B is used for Operation Schoolhouse the HA has to pay for certification which is different from what the town gives the HA. The HA had not received an invoice since 2013 now the HA has to pay catch up from then until now. If the HA did not have Operation Schoolhouse they would not have to pay this but it is because there are children in the building. The HA will need to increase the cost for Operation Schoolhouse.

The HA had a Thanksgiving party for the seniors and it went well. . The office will be closed for the holiday as per the Personnel Policy. The emails will be checked and Bob and Robbie will be on call.

MAINTENANCE SUPERVISOR — Mr. Dekker told the Board about Verizon and how they are in the unit with them while they are doing the work. Maintenance is doing a mini inspection on the units while they are in there. They discussed Fios. He said there were only two apartment turnovers in the past couple months with not much damage at all. Bob said that he met with Dave and discussed the maintenance budget for next year. He said that they made a lot of purchases this year and will be ok next year as a result. He said they were in good shape ending the year.
