CALL TO ORDER: Public Meetings Act, adequate notice of this meeting has been provided in the following manner: on January 6, 2021, a notice of all meetings was provided to the Township of Berkeley Clerks Office, the Asbury Park Press, and was posted on the Authority official public bulletin board at the BTHA's Administration Buildings as well as the BTHA's Website.

PLEDGE OF ALLEGIANCE: All those present recited the Pledge of Allegiance.

A moment of silence was observed.

ROLL CALL: Roll call was read as listed above.

AUTHORIZATION BY THE BOARD TO APPROVE THE MINUTES FOR THE OCTOBER BOARD MEETING: A motion was made to approve the September 28th, 2021, Board meeting minutes, 1st by Commissioner Byrnes and 2nd by Commissioner Pellecchia. All in favor.

AUTHORIZATION BY THE BOARD TO APPROVE FOR PAYMENTS POINTS A THROUGH C: A motion was made to approve the payments, 1st by Commissioner Pellecchia, 2nd by Commissioner Byrnes. All in favor

Commissioner Garibaldi arrived

LEGAL COUNSEL – Legal Counsel stated there were three (3) matters at hand and two (2) families are moving and one (1) is based on HQS inspections and paying back to Housing monies owed through a re-payment agreement.

All courts are now open and all three (3) of our cases were heard by a court mediator.

ACCOUNTANT - Finance committee met to discuss State Budget (5 pages), salary increases.

Accountant noted that Berkeley Housing is not a troubled Housing Authority. Budget reflects a surplus and reserve of \$11,380.00 and it's a realistic standard budget. It was completed with the Director and Maintenance Superintendent's projected input of expenses, if any. State Budget is based on HUD Budget.

Commissioner Ytreboe arrived

EXECUTIVE DIRECTOR – The Housing Authority's 5 Year Annual Plan was approved by HUD. Fraud repayment agreements (3 out of 5) from residents are being collected. We have 2 applications in with the DCA Covid funds for residents.

There was only 1 RFP accounting returned

A budget meeting was held (via zoom) with Chair, Vice-Chair, Director, Commissioner Ytreboe and Dave Ciarrocca.

Motion to Approve Resolution 2021-10-3 for Accounting Services with option to extend; 1st by Commissioner Pellecchia, 2nd by Commissioner Byrnes. Commissioner Garibaldi, Yes; Commissioner Bacchione, Yes; Commissioner Ytreboe, Yes.

Our staff will be spreading Holiday cheer to our residents before the end of year.

MAINTENANCE SUPERINTENDENT – Renovations are still being completed on apartments for transfers and new move-ins. Some renovations are being held up by product backorders. Maintenance is continuing to keep up with resident work orders and maintaining property now with the grounds and leaves. Commissioner Byrnes was asking about hiring outside contractors to help. Dave Ciarrocca said that it was too costly to hire outside contractors to help with the renovations and that it would eat into the budget very quickly and the process (procurement) would take too long. HUD continues to fund the Housing Authority for 70 units.

There was a very heated discussion on renovations and the move-in, moveout process between Commissioner Byrnes and our maintenance superintendent. Commissioner Byrnes made reference to an employee's salary in an open public meeting.
